## Booking Terms and Conditions

### **Registration**

- All parent carers must complete our online registration form before a child can be accepted at a District Sports setting. Registration must be done directly on our website <https://www.districtsportssouth.com/copy-of-contact-us>
- District Sports must be notified of any changes in registration details, as soon as possible, in writing by the parent/carers.

### **Booking Sessions**

- All sessions requested by parents/carers are subject to availability.
- All sessions must be booked and paid for BEFORE the child can attend the club.
- All sessions booked must be paid for at the time of booking using the ClassForKids system.
- Parent carers may consider a booking as being accepted even if not paid for but will be liable to pay the full amount. By booking and using a session you are hereby committing to full payment, unless you have contacted the management team prior to booking and have an alternative agreement such as; one-off sessions or trials.
- If you wish to pay by BACS, please pay the correct amount at the time of booking online followed by a text to confirm you have made the payment and this can be clarified by the management team. Please text: 07858 904422.
- Booking deadlines may vary depending on the club/venue.
- School children who remain at the school/club uncollected beyond the pick-up time will be cared for whilst their parent carers are contacted to collect them.
- Bookings maybe cancelled or changed up to 24 hours before the session start time – changes may not occur after this time and will not be credited or refunded. Termly and course/block bookings can be cancelled but will not be credited or refunded.
- District Sports will credit all fees charged if the club is forced to close due to unforeseen circumstances.

### **Responsibility for attendance**

It is the parent carers responsibility to:

- Ensure that their child(ren) arrive on time.
- Ensure that their child(ren) are aware that they will be attending any session.
- Notify the school & District Sports if there are late changes made to their child(ren)'s club attendance on that day.

### **Grounds for Exclusion**

- Any child who has suffered from diarrhoea, sickness, high temperature/fever, conjunctivitis or any contagious disease must be kept away from the Club for a period of 48 hours after such condition has ceased.
- Should any child suffer from any of the above whilst at the Club, the staff will contact the parent carer and ask them to collect the child as soon as possible.
- Other grounds for exclusion are persistent poor behaviour on the part of the child or the parent carer, (which includes, but is not limited to, bullying, verbal abuse, physical violence, fighting, racial incidents, defiance, rudeness to others, dishonesty, disobedience and deliberate damage to property), or non-persistent incidents of particularly serious behaviour (for example those which endanger children or staff) or where a parent carer is in breach of any of our terms and conditions.
- Refunds will not be made if children are excluded on the grounds set out above.

### **Reservation of Rights**

- District Sports reserves the right to exclude a child or family from attending the Club or to refuse to accept a registration at its sole discretion.
- District Sports reserves the right to close the club on the grounds of staff shortage, unavailability of facilities, or for any other reason, which in its reasonable opinion necessitates closure. Reasonable notice will be given where possible.
- District Sports reserves the right to change these terms and conditions at any time.

### **Legal**

- District Sports accepts no liability for the administration of medicine in accordance with parent carers written instructions. Medicines will not be administered in the absence of written instructions.
- District Sports accepts only medication which is prescribed, in original packaging including the pharmacy label which indicates the child's name.
- District Sports accepts no liability for loss or damage (including consequential loss) to property brought to club premises caused by the actions of children or third parties or for accidental damage caused by club staff.
- District Sports accepts no responsibility for injury caused from pre-existing medical conditions which are not notified to the club.
